### **General terms and conditions:**

1. The November Meditation Retreat for guests cost €199/person/3 nights; for members of the Association costs €149/person/3 nights.
2. The prices listed are final and include all dietary costs.
3. The reservation is valid after payment of 100% deposit for the retreat and after confirmation by the Association.
4. The deposit for the retreat is calculated in the full amount of the retreat, i.e. for guests €199, and for members of the Association €149.
5. Changing or canceling a reservation:
  - 5.1. A change or cancellation of a reservation must always be made in writing, either by a written request delivered to the Association's address, or by e-mail delivered to the Association's e-mail address ([santikaram.slovakia@gmail.com](mailto:santikaram.slovakia@gmail.com)).
  - 5.2. Proof of the change or cancellation of the reservation is a written confirmation of the change or cancellation of the reservation by the Association.

- 5.3.** In case of cancellation of the reservation by the booking party, the Association charges the following fees:
- 5.3.1.** no fee is charged up to 20 days before the start of the retreat (i.e. the deposit is returned in full),
  - 5.3.2.** 20 - 11 days before the start of the retreat, a fee of 25% of the total deposit is charged,
  - 5.3.3.** 10 - 6 days before the start of the retreat, a fee of 50% of the total deposit is charged,
  - 5.3.4.** 5-0 days before the start of the retreat, a fee of 100% of the total deposit is charged (i.e. the deposit is non-refundable).
- 5.4.** Changing the reservation is possible only in justified cases and with the consent of the Association:
- 5.4.1.** free of charge - at least 20 days before the original retreat date,
  - 5.4.2.** with a fee of 10% of the price - at least 15 days before the retreat date,
  - 5.4.3.** with a fee of 15% of the price - at least 5 days before the retreat date,
  - 5.4.4.** it is not possible to change the reservation less than 5 days before the start of the retreat.
- 5.5.** In agreement with the Association, the booker can move the retreat date to another desired date, max. however, 12 months from the original retreat date.
- 5.6.** In a case of the booker's voluntary, early departure from the retreat, the booker is not entitled to a refund of the deposit, or its aliquot part.
- 5.7.** All requested changes or cancellation of the reservation must be made only by the person who signed the original reservation and exclusively through an authorized email address and in connection with such email communication.
- 5.8.** Changes or cancellations of the reservation are only valid upon payment of the relevant fee, otherwise the the booker's statement is considered non-binding until the time of payment of the relevant fee or until the start of the reservation, while the non-attendance of the booker is subject to a fee of 100% of the total deposit.
- 5.9.** If the retreat is cancelled by the Association, the Association reserves the right to cancel the reservation immediately. In such a case, the Association will notify the booker of the cancellation via email and/or telephone, proposing to reschedule the reservation or provide a refund.
- 6.** By signing the reservation form, the booker confirms that he/she has read the Guidelines for visitors to the Santikaram Forest Temple (<https://www.santikaram.com/santikaram-forest-temple>) and during the retreat he/she will follow them. At the same time, the booker undertakes to pay for all possible damage to equipment and real estate that could arise during the retreat due to booker's own fault.
- 7.** By signing the reservation form, the booker confirms that he/she is aware that the Santikaram Forest Temple is monitored by a camera system. For security reasons, images, audio, video, or audio-visual recordings (photos, videos) may be taken in the area and premises of the forest temple. The booker acknowledges and agrees to the production and use of images, audio, video or audio-visual recordings.
- 8.** By signing the reservation form, the booker confirms that he/she agrees to the processing and recording of the data and information specified in this reservation form, exclusively for the internal needs of the Santikaram Association Slovakia, in accordance with Act no. 18/2018 Coll. on the protection of personal data.
- 9.** By signing the reservation form, the booker confirms that he/she understands and agrees to the above General Terms and Conditions.
